
Today we will look at the reform line of the presidents of the United States.


Since 1989, we have 6 presidents:

Ronald Reagan, George Bush Senior, Bill Clinton, George Bush Junior, Barack Obama and Donald J. Trump



Bill Clinton and Barack Obama

Bill Clinton would be connected with Obama because they are both democrats.



George Bush Father and Son

George Bush Senior would be connected with Bush Junior. Bush Senior conducted the first Iraq war or Gulf War although the American people did not want this war.

To convince the people, they had a young girl sitting in congress and saying to the American people that in Kuwait they took just born babies from their incubator and throw them on the floor and let them die. This was a conspiracy theory that was made to make the American people to agree on the Iraq war. But this poor girl from Kuwait was not poor at all, she was the daughter of the ambassador of Kuwait to the USA. She was put there by a firm (Hill & Knowlton) who paid hundred thousand of dollars to deceive the American people. The US government recognized that the Ambassador of Congress Tom Lantos has organized that show in Congress.

Nayirah Testimony

The **Nayirah testimony** was a <u>false testimony</u> given before the <u>Congressional Human Rights</u> <u>Caucus</u> on October 10, 1990 by a 15-year-old girl who provided only her first name, Nayirah. The testimony was widely publicized, and was cited numerous times by United States senators and President <u>George H. W. Bush</u> in their rationale to back Kuwait in the <u>Gulf War</u>. In 1992, it was

revealed that Nayirah's last name was al-Ṣabaḥ (<u>Arabic</u>: (نيرة الصباح) and that she was the daughter of <u>Saud Al-Sabah</u>, the Kuwaiti ambassador to the United States. Furthermore, it was revealed that her testimony was organized as part of the <u>Citizens for a Free Kuwait</u> public relations campaign, which was run by the American public relations firm <u>Hill & Knowlton</u> for the <u>Kuwaiti government</u>. Following this, al-Sabah's testimony has come to be regarded as a classic example of modern atrocity propaganda.

In her emotional testimony, Nayirah stated that after the <u>Iraqi invasion of Kuwait</u> she had witnessed Iraqi soldiers take babies out of <u>incubators</u> in a Kuwaiti hospital, take the incubators, and leave the babies to die.

An ABC report found that "patients, including premature babies, did die, when many of Kuwait's nurses and doctors ... fled" but Iraqi troops "almost certainly had not stolen hospital incubators and left hundreds of Kuwaiti babies to die." Amnesty International reacted by issuing a correction, with executive director John Healey subsequently accusing the Bush administration of "opportunistic manipulation of the international human rights movement". On January 6, 1992, *The New York Times* published an op-ed piece by John MacArthur entitled "Remember Nayirah, Witness for Kuwait?" [57] MacArthur discovered that Nayirah was the daughter of the Kuwaiti Ambassador to the U.S., Saud Nasir al-Sabah. [57] MacArthur noted that "the incubator story seriously distorted the American debate about whether to support military action" and questioned whether "their [Representatives Lantos and Porter] special relationship with Hill and Knowlton should prompt a Congressional investigation to find out if their actions merely constituted an obvious conflict of interest or, worse, if they knew who the tearful Nayirah really was in October 1990." [57] The story earned MacArthur the Monthly Journalism Award from *The Washington Monthly* in April 1992, and the Mencken Award in 1993. [44][58]

The Gulf War

The Gulf War was fought between <u>Iraq</u> and a coalition of nations that included Kuwait, the United States, the United Kingdom, France, Saudi Arabia, and more. It began when Iraq invaded Kuwait on August 2, 1990 and ended with a cease fire declared on February 28, 1991.

Leading up to the War

From 1980 to 1988, Iraq had been at war with Iran. During the war, Iraq had built up a powerful army that included over 5,000 tanks and 1,500,000 soldiers. Building up this army had been expensive, and Iraq was in debt to the countries of Kuwait and Saudi Arabia.

The leader of Iraq was a dictator named Saddam Hussein. In May of 1990, Saddam began to blame the economic woes of his country on Kuwait. He said they were producing too much oil and driving down prices. He also accused Kuwait of stealing oil from Iraq near the border.

Iraq Invades Kuwait

On August 2, 1990 Iraq invaded <u>Kuwait</u>. A large Iraqi force crossed the border and made for Kuwait City, the capital of Kuwait. Kuwait had a fairly small army that was no match for the Iraqi forces. Within 12 hours, Iraq had gained control of most of Kuwait.

Why did Iraq invade Kuwait?

There are a number of reasons why Iraq invaded Kuwait. The primary reason was money and power. Kuwait was a very rich country with lots of oil. Conquering Kuwait would help solve Iraq's money problems and control of the oil would make Saddam Hussein very powerful. In addition, Kuwait had seaports that Iraq wanted and Iraq claimed that the land of Kuwait was historically part of Iraq.

Operation Desert Storm

For several months the United Nations tried to negotiate with Iraq to get them to leave Kuwait, but Saddam didn't listen. On January 17, an army of several nations attacked Iraq in order to free Kuwait. The attack was codenamed "Operation Desert Storm."

Kuwait is Liberated

The initial attack was an air war where warplanes bombed Baghdad (the capital city of Iraq) and military targets in Kuwait and Iraq. This went on for several days. The Iraqi army responded by blowing up Kuwaiti oil wells and dumping millions of gallons of oil into the Persian Gulf. They also launched SCUD missiles on the country of Israel.

On February 24, a ground force invaded Iraq and Kuwait. Within a few days, much of Kuwait had been freed. On February 26, Saddam Hussein ordered his troops to withdraw from Kuwait.

Cease Fire

A few days later, on February 28, 1991, the war came to an end when <u>President George H. W.</u> Bush announced a ceasefire.

Aftermath

The terms of the ceasefire included regular inspections by the United Nations as well as a no-fly zone over southern Iraq. However, in the years to come, Iraq did not always comply with the terms. They eventually refused to admit any weapons inspectors from the United Nations. In 2002, President George W. Bush demanded that Iraq allow inspectors into the country. When they refused, another war called the Iraq War began.

The Iraq War

The Iraq War was fought between Iraq and a group of countries led by the United States and the United Kingdom. It began on March 20, 2003 and ended on December 18, 2011. The war resulted in the toppling of the Iraqi government led by Saddam Hussein.

Leading up to the War

In 1990, Iraq invaded the country of Kuwait and started the Gulf War. After Iraq lost the Gulf War, they had agreed to inspections by the United Nations. By the early 2000s, Iraq was refusing to allow U.N. inspectors into the country. Then 9/11 happened. The U.S. began to worry that the leader of Iraq, Saddam Hussein, was helping terrorists and that he was secretly developing weapons of mass destruction.

What are Weapons of Mass Destruction?

The term "Weapons of Mass Destruction", sometimes just called WMDs, are weapons that can cause harm to a lot of people. They include things like nuclear weapons, biological weapons, and chemical weapons (like poison gas).

The Invasion

On March 20, 2003, <u>President George W. Bush</u> ordered the invasion of Iraq. The U.S. forces were led by General Tommy Franks and the invasion was called "Operation Iraqi Freedom." Some countries allied with the U.S. including the United Kingdom, Australia, and Poland. However, many members of the United Nations including France and Germany did not agree with the invasion. Russia another superpower did not agree.

Shock and Awe

The U.S. used a precision bombing attack and fast-moving troops to quickly invade Iraq. This method of attack was called "shock and awe." Within a few weeks, they had taken the capital city of Baghdad. Later that year, Saddam Hussein was captured. He was put on trial by the new Iraqi government and was executed in 2006.

Coalition Occupation

The coalition forces continued to occupy Iraq for some time. The country was in disarray without Saddam and his government. Different Islamic factions fought against each other and the coalition forces for control of the country. The infrastructure (roads, government, buildings, telephone lines, etc.) of the country needed to be rebuilt.

Insurgency

For the next several years, different groups fought within Iraq for power against the new Iraqi government. A coalition of forces led by the United States remained in the country to maintain order and to help the new government. However, the insurgency continued.


U.S. Troops Withdraw

The Iraq War officially ended on December 18, 2011 with the withdrawal of U.S. combat troops.

ISIS and a Continuing Battle


In the next few years, an Islamic group called ISIS (Islamic State of Iraq and Syria) gained power in areas of Iraq. In 2014, the U.S. sent troops back to Iraq to support the Iraqi government. As of the writing of this article (2015), U.S. troops are still in Iraq combating ISIS.

How Reagan is elected?

In 1979, there is a movement who rose up. It is called the Moral Majority.

The reason why this movement is born is because in the 1960s there is another movement rising up which is known as the Civil right movement. The leading person is Martin Luther King Junior.

He is fighting for the end of segregation between black and white and tries to bring equality.

During this civil right movement, the government starts forcing Christian conservative schools in the southern states to desegregate which means that white and black boys and girls can go in the same school. The government starts holding back tax exemption for all schools who segregate.

But southern evangelicals believed it was a biblical principal to segregate and therefore, if they desegregate, it was against their religious conviction. So, they fought against it.

It was the same mentality in the south 100 years ago that used the Bible to justify slavery.

So, 100 years ago, they use the Bible to justify slavery and a 100 year later, they use the Bible to justify segregation.

And when the State starts to prevent them from segregating their private academy, they all unite under an organization called the <u>Moral Majority</u> and the direction of <u>Jerry Falwell</u>.


Their purpose was for any religious leader to turn from being just a religious organization but become active politically and especially unite with the Republican party because their ideas were as close as the evangelicals.

So, in 1979 they form the Moral Majority and force their church members to vote.

The reason why is because they want to reshape the USA after God's principles and they want to do that through the government. It is another way of saying, break down the wall between church and state. Make State enforce the morality of the majority. The majority being the evangelical party of America.

Jerry Farwell was the leading person extremely conservative, deeply rooted in racism. And Reagan won the evangelical votes.

Connected to this religious movement, you have white nationalism. Falwell was angry that in a nice neighborhood you have white evangelical and a black family next door.



The Rise of a Unilateral Power

During the Cold War, they were two superpowers: The United States and The Soviet Union. At the end of the cold war the USA became unilateral.

There are 3 different types of power: Unilateral, Bilateral and multilateral.


Unilateralism is when there is one superpower who is in control of all the nations. This type of system can lead to dictatorship.

Bilateralism is when you have 2 superpowers are in control and all the other nations are under the hand of one of the two superpowers. The two superpowers are not friendly to one another because they seek to control the nations their own ways.


Multilateralism is when you have many nations working together. Today we use the term globalism. This system is the best because there is not a nation above another one to try to gain control of others. This is what do the United Nations or the European Nations today. Many think this system is bad, but it allows nations to have accountability and run the world affairs. Nations cannot do what they want otherwise they get sanctions. If it is unilateral, you end up with nationalism which most of the time finishes as a dictatorship.

Mikhail Gorbachev wanted a multilateral world. After the cold war in 1989 he sees how the United States rises as a solo superpower which will lead them to become dictator. So, he wants the world to enter into a New world order. Gorbachev called it multilateralism where the United Nations runs the world affairs. Because the Soviet Union is dying, he doesn't want the United States to have much power.

But Georges Bush sees the New World order differently. For him this means unilateralism. He says that there is no substitute to American leadership and determines to have a unilateral world order. And he made it clear in in speech in September 11, 1991 and also when he invades Iraq.



So, from the beginning of our reform line, the world goes from being bilateral to unilateral. There were two world superpowers, the United States and the Soviet Union to one superpower, unilateral system, the USA until they got restrain again. They got restraint because of other issues that were rising up. The rise of Islam after the 9/11 attacks and the rise of Russia after the Iraq war. Bush Junior did not listen to Putin who told him to not go to war with Iraq. He was not the only one. France also asked Bush. But Bush acted unilaterally. Since then, Russia, who didn't like the USA to act as policeman started to gain and build some sphere of influence.



Unilateralism

So, in this history with Reagan and Bush, the world is heading to a new world order, a nationalistic order led by an almost unrestrainable United States of America.

Donald J. Trump

So, if the reform line begins this way with Reagan it is going to end the same way. Donald Trump is not part of the political establishment. Before he became president and after stopping being a businessman, he was a celebrity making money from entertainment and TV reality show.

Reagan comes out of Hollywood; Trump comes out of Hollywood.

Jerry Falwell united the religious right because of their racism to elect Ronald Reagan with the majority of the white evangelical vote.


Before 2016 few evangelical leaders endorsed Donald trump. There's been a sense of fear to do that. Until one man stands up and say, I am endorsing him, and you would have to endorse him also. And this man is Jerry falwell Junior.

With Reagan we have the father, with trump, we have the son. The son leads the evangelicals on that subject as a result 81% of the evangelical voted for Trump. Jerry Falwell Junior sees Trump as the "dream president" for evangelicals because his beliefs are closed to the evangelical ones. Trump is anti-abortion, gay rights, anti-vaccination. He believes in white supremacy etc. Evangelicals see in Trump the one who will enforce the morality of the majority, the moral conservative Christian values enforce to all. They want the union of Church and State.


Already white nationalism is on the rise and we already see a nationalistic world order growing because prophecy foretells that it will be unilateral.

Today the world is back to a bilateralism system with Russia and the United States. So, we need to let go of that conspiracy theory that calls globalism the threat. Globalism restrains power from becoming dictatorial. It is not the threat.
